The role of the Hygiene Operator is to ensure that hygiene levels in the mill are maintained to the highest possible standards. The areas this individual is responsible for must comply with the criteria set out by internal and external feed safety standards. In a drive for continuous improvement this individual will be		
	required to follow a site hygiene improvement action plan in which their performance will be benchmarked and measured against.		
	Their job will involve the use of industrial vacuum cleaners, anti- bacterial sprayers and other cleaning equipment. In addition to this to improve hygiene standards they will also be required to perform other hygiene duties such as degreasing equipment and painting.		
	It is also expected that the Hygiene Operator will learn other job roles on site. The individual must be of a very flexible nature and be willing to be called upon at short notice to cover any job that they are trained to do in order to meet the needs of the site and business.		
	The individual must possess excellent Team working skills and be able to assist others in their roles.
